### **Performance Frameworks and State Accountability**

As the 2024 performance frameworks process concludes, our team is already preparing for 2025 frameworks. With the release of the [1241 Taskforce's final report](#) in November, we will provide periodic updates on how things are progressing in the policy arena. Currently, an accountability bill is being drafted but it has not yet been introduced by the legislature. We are anticipating that any proposed changes will be phased in over time - in other words, we are not planning on any big changes for the 2025 performance frameworks at this time. However, we will certainly keep you posted if that changes.

### **Accreditation Contracts**

Thank you to all districts that completed their accreditation contracts this winter! We are getting signatures from the Commissioner and State Board President added now and should have contracts available online soon.

### **Career Development Incentive Program (CDIP) Program Updates Webinar**

Just a reminder that the CDIP data collection is where we gather some of our data for the Postsecondary and Workforce Readiness (PWR) indicator in the performance frameworks. CDE and the Colorado Workforce Development Council are offering a webinar about the 2024-2025 CDIP program updates, how it relates to accountability, as well as a review of newly approved certifications, removals and updated guidance on apprenticeships. ## **January UIP Review Feedback**

Schools and districts on Performance Watch (i.e., Priority Improvement, Turnaround, On Watch, On Hold) or ESSA Comprehensive Support submitted in January are being reviewed by CDE staff. Feedback will be shared with district accountability contacts and will be available in the Collaborate Tab of the plan Online UIP System as it is available.
