1	CHAIRMAN DURHAM: I think it's always
2	advisable to submit to current law. And that's our best
3	estimate, the current law. It's also appropriate to advise
4	the legislature. There are ways to achieve some savings
5	should they elect to do so. But I think the Budget
6	Committee is theoretically obligated to appropriate to
7	current law so okay. All right. Yes, Doctor Scheffel?
8	MS. SCHEFFEL: Can I just ask you just a
9	context question? So we look at the budget every year. Can
10	you just remind me of the timeline for the budget in which
11	we look holistically at the budget? And this is an
12	additional piece. Can you speak talk to the timeline?
13	CHAIRMAN DURHAM: Please.
14	UNIDENTIFIED VOICE: Mr. Chair. Well, Board
15	Member Scheffel, I'm not sure, we we did begin showing it
16	to you last year, and I want to say that was in fall time
17	frame. And that's mostly because the the submission
18	really starts being developed in terms of nuts and bolts
19	from August to about October. So we would have something to
20	look at in a draft form probably mid to late September. But
21	it wouldn't actually be final, particularly total program
22	and school finance are sometimes the last thing to be set
23	because it's the biggest line in the state budget, so they
24	arrange everything kind of around it, and save it for last.



- 1 So we would have draft documents to look at early to mid
- 2 fall.

- 4 CHAIRMAN DURHAM: Okay. Further questions?
- 5 Thank you very much. I appreciate it.
