

  - ► Emphasis: educational materials
- ▶ 2015: \$2.5M
- ▶ 2019: \$3M
  - ▶ Early literacy footnote removed
- ► 2020: \$2.5M
  - ▶ Reduced due to pandemic concerns
- ▶ 2021: \$3M





### The How requesting your funds


- Funds must be requested on a reimbursement basis
- Nothing will be sent without a request
- ► The request for funds/drawdown form is online
- ► Two-step process: initial request and then verification
- Invoices/receipts are <u>not required</u> for submission with your request
- Last day to request funds is June 30, 2022

- Funds must be requested on a reimbursement basis
- Requests can be made on purchases made between July 1, 2021 and June 15, 2022
- ► Receipts/invoices are <u>not required</u> for submission with request for funds form.
- ▶ Last day to request funds is June 30, 2022!
