

House Bill 24-1063: Abbreviated School Day Policy Assurance

CDE Model Abbreviated School Day Policy Requirements

As required by House Bill (HB) 24-1063, the Colorado Department of Education (CDE) has developed a <u>model policy</u> to clarify "when and how abbreviated school day schedules may be implemented" in compliance with the requirements of the Individuals with Disabilities Education Act (IDEA), Section 504 of the Rehabilitation Act of 1973 (Section 504), and the Exceptional Children's Educational Act (ECEA).

By July 1, 2025, all Administrative Units (AU) are required by state statute to adopt and implement the CDE's model policy or adopt a policy that substantially conforms to CDE's model policy and meets the minimum requirements described in ECEA 8.01(1)(j). Adoption may look different between AUs, but the finalized policy must make it clear that the requirements described within are binding for all employees who will be responsible for implementing the policy (see options below). For children identified under IDEA, compliance with HB 24-1063 for abbreviated school days and abbreviated school day schedules will be subject to ongoing monitoring consistent with CDE's responsibility for general supervision under IDEA 34 C.F.R. § 300.600 and ECEA 7.05.

Compliance with ECEA

To ensure compliance with HB 24-1063, CDE requires each AU to sign an assurance that it has adopted CDE's model policy or will submit the policy the AU intends to adopt via the <u>ESSU Data Management System</u> (<u>DMS</u>), <u>no later than July 1, 2025.</u> The CDE understands that local Boards of Education may need to adopt this policy. If your AU is unable to do so before July 1, 2025, please make sure the policy adoption occurs no later than the first day of school for the 25-26 School Year.
