ELAT students need to be assessed within the first 30 calendar days of school . <i>Kindergarten</i> <i>consideration:</i> Through a provision in HB15-1323 you may choose to use up to 60 calendar days for initial benchmarking. However, we would encourage districts to continue with best practice by benchmarking and providing support early in the year, within the first 30 days. Completion of your READ BOY assessment within the 60 days will inform the literacy component of your readiness assessment.	Each district needs to pick a 2-week window within one of the following timeframes. Please pick either December 2, 2019 - December 20, 2019 OR January 6, 2020 – January 24, 2020	April 27, 2020 – May 15, 2020

Selecting Benchmark Dates:

- BOY Benchmark within the first 30 calendar days of your school year (see note above regarding kindergarten). CDE does recommend that benchmark periods are contained to a 2-week window whenever possible.
- MOY Benchmark December 2nd December 20th OR January 6th January 24th
- EOY Benchmark April 27th May 15th

Preparing to Assess with the Amplify System:

- Go to <u>setting your 2019-20 DN BM windows</u> by **August 24, 2019** to set your benchmarking windows. This is an important step to ensure that the correct assessments are displayed for your teachers.
- Prior to your first day of assessing, the district will need to update student rosters in the Amplify system (see page 15 for more information on how to complete this task). Please note that all students in the system from 2018-2019 have been graduated up to the next grade level once you roll over (July 26th is the default date for this).

Professional Development - Information and Registration

Through the ELAT (Early LiteracyAssessment Tool) Project, CDE and Amplify are providing multiple professional development opportunities across each of the eight regions of Colorado.

Important Updates

UPDATE: Interim Assessment Name Change

The Dynamic Measurement Group (authors of DIBELS Next) has changed the name of DIBELS Next to Acadience Reading. It's important to note that the **content of the assessment will remain the same.** Additionally, the **current materials, training, and software provided by Amplify through the Early Literacy Assessment Tool (ELAT) Project will all remain current and usable**; this is simply a change in the assessment name.

Starting at Back to School of 2019, you will see the following messaging when you log into mCLASS.amplify.com, go to the Reporting and Analysis Suite or log into the App:

DIBELS Next is now called Acadience Reading. Acadience Reading is a registered trademark of DMG, the authors of Acadience Reading

mCLASShome.com has CHANGED to mclass.amplify.com as of July 1st

mCLASS reporting, the mCLASS app, and mCLASS student assessment all have new domains. For mCLASS reporting and student assessment, teachers and students can navigate directly to the new URL as of 7/1. mCLASS App Updates

When teachers access the mCLASS app after 7/1 using the old <u>URL</u> (mclasshome.com/assessment), they will be directed to a page that instructs them to:

- 1. Sync data (if they haven't previously)
- 2. Create a shortcut for the new domain
- 3. Delete the shortcut for the old domain

Teachers should then conduct assessments from the new URL/shortcut moving forward.

3. Delete your old shortcut Be sure to delete the old version of the mC after you've created the new one.	LASS app

However, if your district has a mobile device management (MDM) system, we suggest that you create the new shortcut. When the school year starts, have teachers first use the old shortcut to sync data and then instruct them to use the new shortcut to assess moving forward. After the completion of the beginning of year benchmark, use the MDM to delete the old shortcut across all of the district's classroom devices.

mCLASS:Home Connect Parent Resource Site

Many of you have asked for an expanded set of resources to share with parents. <u>This site</u> will provide information and activities for parents in addition to the Home Connect letters already available. Parents can learn more about each literacy area and access activities to use at home to support their children. Activities are available in English and Spanish.



Boost Mobile app gives students additional practice. Boost is a mobile app students can use to continue practicing their skills outside of intervention or at home.

The app has several games through which students practice skills ranging from



phonological awareness to advanced phonics. Each game in the app is linked to a specific early literacy skill. Students are presented with images,letters, letter combinations, and words, and must match them to the sounds that they hear. New games, with more advanced skills are automatically unlocked as students progress and become more proficient in earlier skills. We have step by step directions to help you <u>get started</u> <u>with Boost</u> in your classroom!

mCLASS Instruction

Shortening the distance from data to instruction mCLASS:Instruction brings all of your Now What? Tools and additional resources into one place: small group, individual, teacher-led, and student-led. As Timmy's teacher, I can quickly see which small group he is part of and the list of reading skills he is struggling with based on his mCLASS DIBELS:Next data. I can immediately access instructional activities to use with Timmy to fill his gaps, and I have access to new comprehension-focused lessons and passages. Additionally, I can view the Boost dashboard so I can gain insight into Timmy's usage and progress. Additionally, mCLASS:Instruction provides seamless integration with two instructional

Pathways of Progress (PoP)

Pathways of Progress provides an evaluation of individual student growth or improvement over time, compared to other students with the same level of initial skills. You can review the pathway growth at both MOY and EOY composite and measure levels.

- When combined with the DIBELS Next benchmark goals and DIBELS Next Composite Score & Measure Level scores, PoP provides teachers with a frame of reference for examining where their students are, specifying where they need to get to, and evaluating whether they are making adequate progress.
- The goal-setting tool is next to Composite Scores for each time of year on the Class Summary.
- Pathway indicators are on progress monitoring graphs and rates of progress are next to the individual DIBELS Next measures.

Note: There is no benchmark goal for Letter Naming Fluency (LNF). This is a summary of the DIBELS Next benchmark goals. For a full description, see the DIBELS Next Benchmark Goals and Composite Score document available from http://dibels.org/. DIBELS is a registered reademark of Dynamic Measurement Group, Inc. Progress Monitoring

Administer as follows:

- 1. Students scoring at Well Below Benchmark (intensive support): at least once every 7-10 days
- Students scoring at Below Benchmark (strategic support): at least once every 10-12 days
- 3. Within the READ Act and ELAT there are no requirements for progress monitoring Benchmark and Above Benchmark students.
 - Best Practices would include progress monitoring to ensure that students remain on track to achieving the next reading milestones.
 - Considerations for Progress Monitoring B/AB:
 - Progress monitoring for these students could occur in a timely way to inform instruction
 - Remember that all green is not equal. You may want to monitor those students who are at the lower end of benchmark
 - Progress monitoring data should always be used to inform instructional next steps

Important: The ability for the CDE to compile accurate assessment data for your district and school is directly impacted by the accuracy of your data.

Self-Service Enrollment:

You may want to consider using our self-service enrollment system. This system allows you to upload spreadsheets to keep your rosters up to date. You can find more information about this system within our <u>Help Section for Self Service</u> <u>Enrollment</u>.

mCLASS® Enrollment: Auto Self-Service Enrollment

Auto Self-Service Enrollment (Auto SSE) is an Amplify service that automatically sends enrollment data from your computer to mCLASS® using our Secure Landing Zone service. Any district that uses mCLASS products can use Auto SSE to update enrollment information.

Unlike manual enrollment and the Self-Service Enrollment (SSE) tools, which require your presence during the upload, Auto SSE can be scheduled and run without your intervention. Auto SSE reports success or any issues by email and on screen, in standard output. The Secure Landing Zone incorporates both authentication and authorization to keep file transfer secure. You must have a verified mCLASS account with a username and password, your account and district must be authorized by mCLASS to initiate a transfer and access the Secure Landing Zone, and you must be root- level user. As with manual enrollment and SSE, there is no fee or charge when you run Auto SSE. You are encouraged to run this service to process your enrollment records as often as necessary.
