## **BACKGROUND INFORMATION**

**EDID Number** – A **unique** eight-digit numeric field containing the random eight-digit value assigned by CDE to the educator whose record is being submitted for processing. Note: A value of eight spaces can be placed in this field if the data being submitted is for a new educator who has not been assigned an educator identification number by CDE (EDIS READ)

**Social Security Number** – The nine-digit numeric value of the educator's Social Security Number. This nine-digit field is REQUIRED and if left blank will result in an error

**School District/BOCES Code** – A unique four-digit number assigned by CDE to each school district or BOCES. This four-digit field is REQUIRED and if left blank will result in an error.

**LAEDID Number** – A ten-digit number assigned to each educator by the reporting district/BOCES. This ten-digit field is OPTIONAL and may be filled with ten spaces

Educator's Last Name – The thirty-character field contains the educator's last name. This thirty-digit field is REQUIRED and if left blank will result in an error

**Educator's First Name** – The thirty-character field contains the educator's first name. This thirty-digit field is REQUIRED and if left blank will result in an error

**Educator's Middle Name** – The thirty-character field contains the educator's middle name. Blanks are NOT allowed. Use NMN (no middle name) when appropriate. This thirty-digit field is REQUIRED and if left blank will result in an error

**Educator's Date of Birth (DOB)** – An eight-digit numeric field contain the month, day, and year on which an individual was born (i.e. 09151989). The date must be a valid date in the form of MMDDYYYY. This eight-digit field is REQUIRED and if left blank will result in an error

**Gender** – An individual's sex.

01	Female – identifies as female (including a transgender student/staff who identifies exclusively as female).
02	Male – identifies as male (including a transgender student/staff who identifies exclusively as male).
03	<b>Nonbinary</b> - does not identify exclusively as male or female. Nonbinary does not refer to a transgender student/staff who identifies exclusively as either male or female
