Announcement - Dr. Foster announced that a Colorado Open Records Act (CORA) request from Chalkbeat Colorado was submitted to the CDE for SB 21-274 survey results / data per the work group's work this past year.

1. Further Travels of the Work Group Report (Slides 5-7)

The Joint Budget Committee Education briefing was November 21, 2022. The work group reviewed the target population and venn diagram. Responses to the recommendations and current work align with Design Thinking - updating definitions, ideas, and prototyping. Additional questions from the JBC and staff will continue to be addressed.

Several work group members listened to the hearing. One member wondered about the comments/concerns about putting more money into the system, when sites are still closing. Providing the JBC with more context will be important.

2. Stewardship of the Work Group's Recommendations (Slide 8)

Dillinger RAD reviewed a revised version of the baseline funding model. The baseline funding is the most costly recommendation, and various ideations are being considered. Size/scale, attraction of new sites, and sustainability are all considerations. The intent is to build/realize economies of scale with small sites, attract new sites, and sustain all sites. The initial baseline structure is based on staffing while the next iteration establishes a threshold of 16 students, then transitions to a per pupil amount.

The Work Group was generally supportive of this methodology. Feedback - The new iteration makes sense, just need to ensure critical staff are included in the 16 count threshold. Questions - How will student count be determined, and what is the timing of that? One time per year, twice per year? Responses - The notion of a "true-up" for student count mid-year has been suggested. December 1 count has traditionally been used for facility schools.

- Focus and stay on track with the agenda and tasks at hand.


- Create a safe environment to discuss disagreements.

- Come to the meeting prepared; adhere to timelines.
- Allow folks that are speaking to finish their comments without interruption.
- Assume positive intention.
- Respect voices for representing constituencies.
 (Appreciate that members may serve as liaisons to a constituency).
- Good access to materials. Maintain the Google drive with the background information which will help us and aid transparency.

How do we maximize impact for students?



- The Work Group prioritized developing recommendations that would provide the maximum impact for the students of Colorado.
- Information collected from school districts across the state as well as students, parents, guardians, and advocates helped the Work Group to develop a student focused framework that was utilized to develop recommendations to guide impactful and sustainable system level change.
- Three distinct groups of students were identified and recommendations were designed to address their unique needs.
 - Current Facility Students Expand existing resources and ensure quality education and treatment at Facility Schools
 - Qualifying Students- Expand available slots and develop mechanisms to support students in their home districts whenever possible.
 - Students with Expanded Needs- Expand the continuum of Facility Schools to help ensure that all student needs are being met

Stewardship of the Work Group's Recommendations

GOOD questions emerged during and after the briefing on November 21st, based on the detailed requirements of SB21-274.

Additional definition, ideas and (fiscal projection) prototyping were requested, particularly with regard to the Baseline Funding model.





Comments or theme's from JBC Analyst's presentation include –

- Appreciation for the work of the workgroup was shared several times.
- JBC chairwoman, Senator Zenzinger, is supportive of the workgroup and recommendations.
- Amanda did recommend that the JBC authorize staff to work with CDE on a bill draft to incorporate the work group's recommendations.
- There is deep concern for students that may not be receiving appropriate educational services –
 they recognize the gravity of the situation and are all interested in further exploration of the
 issue.
- Key issues that need to be flushed out and will need workgroup support include 1) Further
 definition/clarification of the target population, 2) Further detail and actual cost projections of
 the baseline funding model and addition of a new school type on the continuum, and 3)How to
 track student success over time.

Baseline Funding Methodologies

Projected Baseline Funding (Methodology Comparison)



Various options are being considered around how the baseline funding model would be calculated. An alternative methodology would be to fund by position up to 16 students and then pay on a dollar per pupil.
