FISCAL YEAR 2022-23

Federal regulation 34 CFR §300.115 requires each local education agency (LEA) to ensure a continuum of placement alternatives to meet the educational needs of students eligible for special education services. The student's Individualized Education Program (IEP) team is charged with developing an individualized plan for the student and determining the most appropriate placement for the implementation of the IEP. In some cases, the IEP team may determine the most appropriate placement to be an approved facility school. Approved facility schools may charge tuition to the responsible LEA for the additional cost of providing special education services to students with disabilities. [ECEA, 1 CCR 301-8, 2220-R-9.01(8)]. The tuition rates are calculated by CDE annually according to ECEA Rule [ECEA, 1 CCR 301-8, 2220-R-9.06(1)(e)]
