- Work Group members discussed data collection for waitlists, and multi-site agencies - and asked 'what questions do we want data to answer'? Members affirmed that exploration of the uniquenesses of multi-site Facility School was a topic of interest.

4. Medicaid Reimbursement - continual learning

- Guests from HCPF provided further information regarding Medicaid and School-based Services. Materials prepared by HCPF and the Question and Answer document will be accessed again in January for further conversation.

5. Rulemaking update

- Work Group members received an update of the calendar and timeline for rulemaking activities affecting facility schools in general and specific to SB 23-219.

6. Work Group Design Thinking - a review

- The facilitator reviewed the actions that pertain to the Design Thinking model, a tool for 'solving' complex challenges, which was utilized in the past for generating recommendations and can be used in the future.

- Allow folks that are speaking to finish their comments without interruption.
- Assume positive intention.
- Respect voices for representing constituencies. (Appreciate that members may serve as liaisons to a constituency).

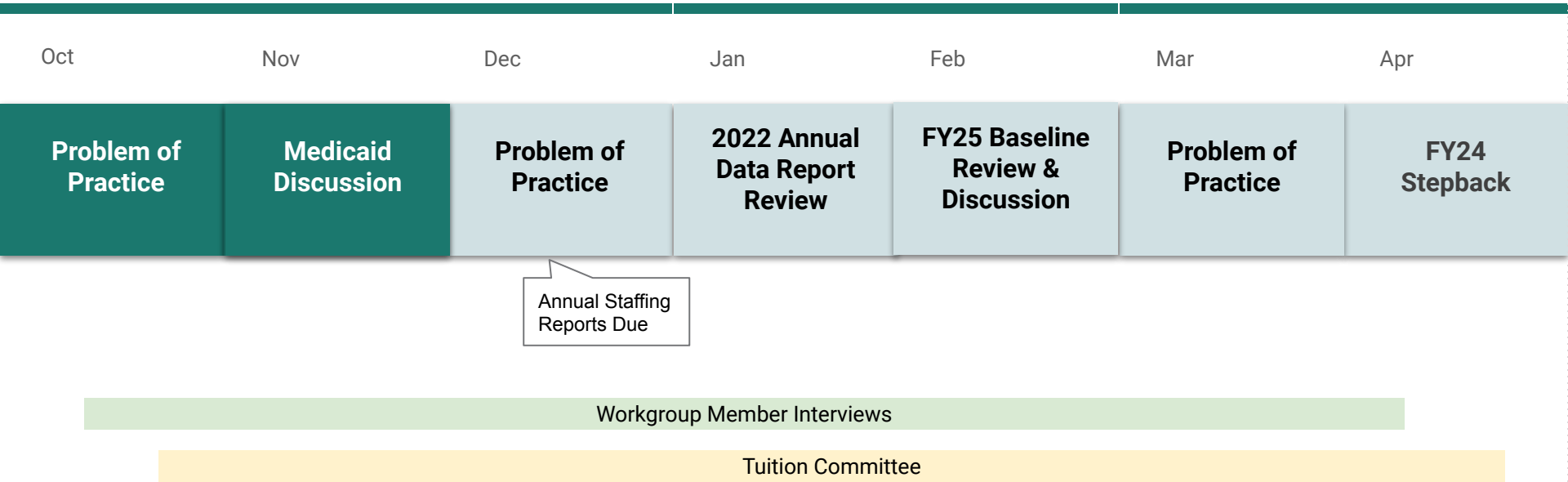
Success is ensuring that we're on track to having an appropriate facility School spot for most (or all!) of our Colorado young people that need them and the facility schools serving them feel supported in that.

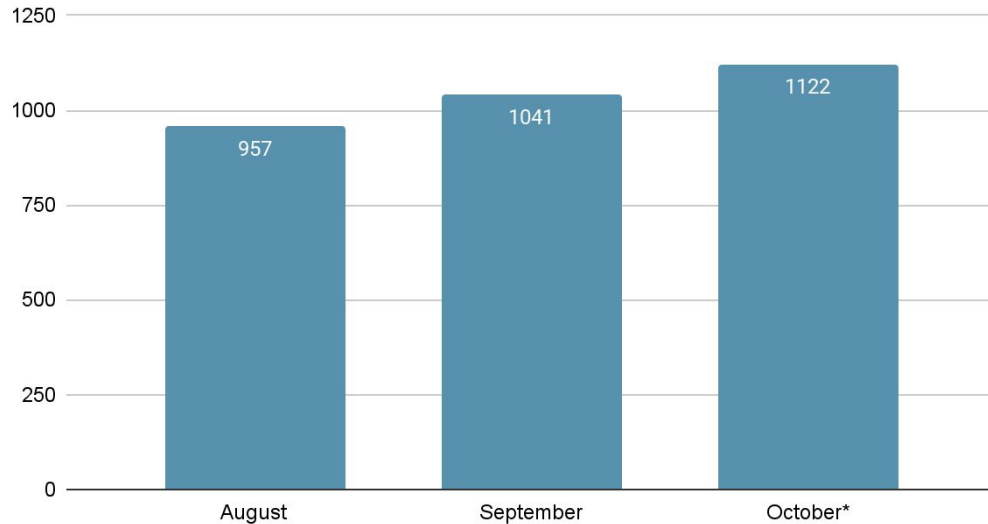

Data Review for SY 2324 - a snapshot

of Unique Students Served per Month



Open Seats & Waitlists

21 Facility Schools indicated they have an average of at least 1 open seat; **25** indicated they have on average at least 1 youth on a waitlist; **14** indicated they have both.

Outstanding Questions

1. What are main drivers around empty seats and waitlists?
2. Is the number of unique students served increased?
3. Are the number of total students served for the entire SY increasing?

* October includes Southgate Hospital (an additional 97 youth)

Prioritizing the Deep Dives With Some of the Data Being Collected

Here's what we believe you emphasized...

a) Time on waitlists, no waitlists, are kids on waitlists at multiple Facility Schools?

Broad questions: Is the System additionally optimized with waitlists or without? Will we have less kids on waitlists over time because we have increased capacity in a school or multiple schools?

(b) Uniquenesses of multi-site Facility School corporations or agencies; opportunities/challenges/benefits.

Broad Question: Do we need to relook at the way multi-sites are currently funded and check on our original assumptions?

Medicaid Reimbursement Funds - Implementation of SB23-219

SB23-219 Requires the department of Health Care Policy and Financing (HCPF) and the work group to consult - to recommend a plan to provide guidance to approved facility schools on the eligibility standards required to request and receive medicaid reimbursement funding for therapeutic services to reduce reliance on school district revenue for therapeutic services.

Let's learn **more** about School-based Health Services - are there opportunities for funding to be directed to approved facility schools?

Facility Schools Board Rules

- Rulemaking Hearing in December, 2023
- Finalization and implementation in January, 2024
- Includes addition of specialized day schools and accreditation information, as well as legislative cleanup



Public School Finance Rules - State Board

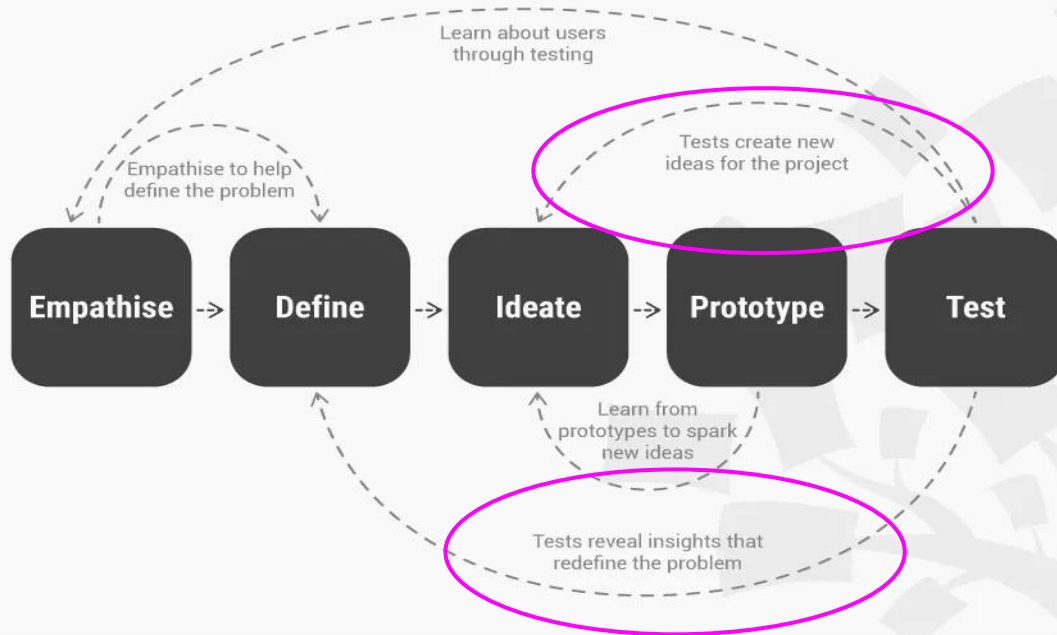
- Notice of rulemaking in December, 2023
- Rulemaking hearing in February, 2024
- Includes revisions for approved facility schools per SB23-219 for new funding model

Exceptional Children's Educational Act Rules - State Board

- Notice of rulemaking in March, 2024
- Rulemaking hearing in May, 2024
- Includes revisions for approved facility schools and tuition cost rates, as well as new baseline funding model
