FSCP and Chronic Absenteeism





Definition of **Chronic Absenteeism**:

A student absent 10 percent or more of the days enrolled during the school year is chronically absent. All absences are included – unexcused, excused and suspensions. The rate is the percentage of students enrolled who are chronically absent.



Chronic Absenteeism is a Statewide Priority

Commissioner Cordova's message of October 6:

"... Though many of our districts have been working hard to improve attendance and have seen some improvements, we still see a statewide chronic absenteeism rate of 31% – that's the percentage of students who are missing more than 10% of school for excused and/or unexcused absences. Some student groups have even higher rates – including English Learners at 39%, students who qualify for free or reduced lunch at 43%, and homeless youth at 59.5%.

It isn't hard to see the link between our achievement data and chronic absenteeism. Our gaps in achievement and attendance are largest for these same groups of kids. Students need to be at school to learn, establish positive relationships and access support. We're not going to be able to improve outcomes for kids without everyone – including students, educators, parents, grandparents, other caregivers, and community members – making a renewed effort to get our kids to school regularly.

I'm grateful to Johann Liljengren and the whole team in the **Office of Dropout Prevention and Student Reengagement** along with our partners in **Data Services** for elevating this issue. We have not done a release on these data in the past, but the alarming absenteeism rates need to be shared widely so we can work together to get students to attend school regularly. I also want to give a shoutout to Darcy Hutchins in the **Family, School, Community Partnerships Office** for sharing promising practices on increasing attendance."

FSCP as an Improvement Strategy: Home Visits in Connecticut

April 2021 - The Learner Engagement and Attendance Program is launched

Summer 2021 - Home visits conducted with students identified as chronically absent from a targeted sample of 15 districts

Spring 2022 - Researchers conduct a mixed methods study on the LEAP home visit intervention.

A Targeted Approach:

- Students+Schools with High Chronic Absenteeism,
- Transition years (K,6,9)
- Student groups with higher rates of CA

Conducted by:

• Staff and Community-Based Partners

Outcomes:

- Overall growth in attendance of 4 percentage points, rising over time to 7-15% over 6 months.
- 16% Middle/High School vs 8% Elementary School
- Similar outcomes across demographic groups, with exception of EL, who showed roughly half the growth of non-EL.

FSCP as an Improvement Strategy: Home Visits in Connecticut

What providers and families noted as the main benefits of the home visit program:

- Improved Family-School Relationships
- Increased Student Attendance
- Increased Student Engagement
- Increased Student Achievement
- Increased Feelings of Belonging
- Increased Access to Resources for Families
- Increased Expectations of Accountability
- Greater Gratitude and Appreciation

And the main challenges:

- Resistant Teachers
- Resistant Families
- Fearful Families (e.g., Afraid of Deportation)

What providers and families say about what they believed to be important in increasing student attendance::

- Personalized, Dynamic Support: Dependent on Family's Needs
- Continued Training and Support for the Visitors
- A Process of Collaboration (e.g., Determining Caseload Assignments)
- Home Visitor Fluency in the Language Used in the Home
- Commitment to Establishing Connections with Families
- Collaborative Advocacy for Students (e.g., Parents, Home Visitors)

FSCP as an Improvement Strategy: Post-Pandemic Solutions

Districts with the strongest scores for family engagement had lower chronic absenteeism rates. This was particularly true in places recognized for a welcoming environment and for sharing power with families through their input and advocacy. The playbook focuses on strategies that 1) **increase awareness**; 2) personalize communication; and, 3) include home visits.

FSCP as an Improvement Strategy: Post-Pandemic Solutions

Increase Awareness: Families are alerted to the magnitude and impact of chronic absenteeism Personalized communication practices:

Focus on empathy, how the school can help families, and what specific things families can do. Avoid focusing on punitive messages that leave parents feeling blamed
Include printed personalized postcards or letters,

rather than just texts

- Provide precise, personalized information rather than generic messages
- Send repeated communications throughout the Year
 <u>Home Visits</u>: Teachers and other staffers meet with parents outside the school setting
