#### 9:25 CDE Office of FSCP Updates

Dr. Darcy Hutchins asked attendees to complete the Google form for the Annual Report that is due on November 22, 2024. Darcy shared that Jes Stroope created a "trail map" for the CDE Office of FSCP website. Darcy pointed out the highlights of the trail map. Darcy shared that SACPIE has been written into the CDE Strategic Plan to integrate and elevate family and community partnerships to increase student engagement. Johann Liljengren shared the top highlights of the CDE Strategic Plan.



#### **9:30** The group took a five-minute break. **9:35 FSCP and Attendance by Johann Liljengren**

Johann Liljengren gave and update around attendance with regards to dropout prevention. He stated that CO is seeing progress in the key metrics of attendance rates and chronic absenteeism though there is variation across grade levels. There are also variations across instructional program service types such as homeless, multilingual learners, low income, migrant, and special education. Colorado's goal is to reduce chronic absenteeism by 50% from it's pandemic high. Colorado has an attendance challenge going on along with 14 other states. It is highlighted on the CDE website with resources and tools. Johann discussed the theory of change in the CDE Strategic Plan. He led brainstorming with SACPIE members regarding their work this year with regards to attendance for support to build up district capacity. The group discussed what other types of materials or resources would be helpful for them or families they work with, and what other types of materials or resources would be helpful for schools and districts. # 10:45 Student Engagement: Understanding It, Seeing It, and Partnering to Address It with Rebecca Winthrop from the Center for Universal Education at Brookings

Rebecca Winthrop presented on her recent research on student engagement and her book, "The Disengaged Teen." Rebecca highlighted the big takeaways from her research. #1: Student engagement matters. It's not just a "nice to have." We have an epidemic of student engagement and engagement is essential to student outcomes. #2: Student disengagement can be hard to see. It's hard to see what they feel and think. There is a new framework to help fully see engagement. There are four modes of engagement within the framework. They are the resister, explorer, passenger, and achiever. #3: Family engagement is essential to student engagement. Rebecca talked about the path to chronic absenteeism and why family-school partnership is needed within each of the four modes within the framework. She has an engagement toolkit: What parents and teachers can do. She discussed with SACPIE members on what ideas they have for sharing this information with families and schools and what strategies should she consider using to disseminate the book and its messages. One attendee mentioned getting the book into public libraries. Another attendee mentioned a short 30-minute webinar for parents.
