I have one caveat. I want the teachers to discuss the history and positive impacts on our communities of minorities and LGBQT community. But I don't need teachers to be forced to teach it during every history lesson. A 10-15 minute review/discussion periodically, or highlighting our heroes when appropriate will be sufficient. From these stds, it appears the minority language has been jammed into every session (history and social studies in particular), and that seems a little overkill, and likely to irritate some of our teachers. To whom it may concern,

I am writing in SUPPORT of the revised Social Studies curriculum. Please read my letter aloud in the meeting April 12-14.

As the mother of a Black student in the St Vrain Valley School District, I am deeply aware of the lack of representation in my son's education. It is vital that my son and others like him see people resembling them in their education. Learning about people from marginalized cultures validates my son's existence. It strengthens him as a student, as a citizen of the United States, and as a person. Likewise, his white peers need to learn about the amazing contributions of Black folks in this country's history. It is not always comfortable to talk about decisions that were made in the past, and that is why this curriculum is even more important. Teachers must be empowered, trained, and supported to facilitate these more difficult conversations between students of all colors and orientations.

As a nurse practitioner, I see firsthand the danger of depression in our youth. Colorado has a startlingly high suicide rate, particularly among young men. I fear for my own son's life as he continues through his education, especially if the school's curriculum leaves him feeling invisible and invalidated as a Black male. My son is just one of many youth from marginalized cultures whose mental health could be supported with this revision in the Social Studies curriculum.

The beauty of American freedom is that we are not tethered to one view and that we have the freedom to learn from one another. I am grateful to live in the state of Colorado and to be able to support the revised K-12 Social Studies standards.

Thank you for taking the time to read this email. And thank you for validating the worth of my son and so many others like him.

I am writing in SUPPORT of the revised Social Studies curriculum. Please read my letter aloud in the meeting April 12-14.

As the mother of a Black student in the St Vrain Valley School District, I am deeply aware of the lack of representation in my son's education. It is vital that my son and others like him see people resembling them in their education. Learning about people from marginalized cultures validates my son's existence. It strengthens him as a student, as a citizen of the United States, and as a person. Likewise, his white peers need to learn about the amazing contributions of Black folks in

this country's history. It is not always comfortable to talk about decisions that were made in the past, and that is why this curriculum is even more important. Teachers must be empowered, trained, and supported to facilitate these more difficult conversations between students of all colors and orientations.

As a nurse practitioner, I see firsthand the danger of depression in our youth. Colorado has a startlingly high suicide rate, particularly among young men. I fear for my own son's life as he continues through his education, especially if the school's curriculum leaves him feeling invisible and invalidated as a Black male. My son is just one of many youth from marginalized cultures whose mental health could be supported with this revision in the Social Studies curriculum.

The beauty of American freedom is that we are not tethered to one view and that we have the freedom to learn from one another. I am grateful to live in the state of Colorado and to be able to support the revised K-12 Social Studies standards.

Thank you for taking the time to read this email. And thank you for validating the worth of my son and so many others like him.



Please be sure to preserve and protect honesty in education. Recent trends of banning books or calling certain topics too "uncomfortable" for children are very concerning. We need our children to learn, from an early age, about the good and the bad, the beautiful and the ugly parts of our past and our present.

- 1. Children who see themselves represented in the books available to them at school have better mental health.
- 2. Providing representation of all types of families, all genders, races, religions makes those things less "other" and reduces bullying and violence.
- 3. The old adage about those who do not learn from history are doomed to repeat it is a good one. We need to learn about the bad in our collective history so we can recognize it and avoid making the same mistakes. Pretending our history is all sunshine and excellence is a lie that will result in a lot of problems.
- 4. The presumption that children are "too young" to hear about troubling things is, in itself troubling. Very young children are constantly dealing with difficult things. Many children are dealing with poverty, hunger, violence in their homes and/or neighborhoods. Giving them space to understand that they are not alone in dealing with these issues can help them find ways to improve their own lives and the lives of those around them.
- 5. Privileged children need to develop empathy towards those less fortunate. If they are never exposed to "uncomfortable" topics, they are going to be wholly unprepared to meet the real world one day.
- 6. Even privileged children encounter uncomfortable issues in their lives. We need to allow them to know they are not isolated and that there are tools available to cope and to perhaps make things better.
- 7. Teachers WILL encounter situations and conversations that are "uncomfortable." They should not feel like they are unable to contribute to or guide the conversations without risking their jobs. Teachers need to be able to actually teach in the moment and with honesty.

Our society functions at it's highest levels when all people feel included, respected, and heard. Limiting school teaching and conversations to topics that are "safe" and "positive" does NOT accomplish this. Limiting teaching to "safe" topics specifically excludes marginalized people from the conversation and pushes them further to the margins of society, where it is difficult for them to contribute.



To Whom It May Concern:

I am writing to submit updated commentary re: revised social studies standards. I initially wrote in support of the new standards, but now that the LGBTQ content has been removed from the K-3rd standards I must revise my comments. I am writing as a parent, former teacher, current teacher educator and scholar of education policy and gender and sexual diversity in schools. Erasing LGBTQ people from the curriculum are harmful and misinformed. When my son was in 2nd grade, he was bullied for having 2 moms. Children in his class told him his family was either impossible or a "stupid fake" family. Schools are responsible for the health and well-being of all children. Here are 6 reasons why we need LGBTQ-inclusive education at all grade levels and I urge you to adopt the standards drafted prior to the removal of LGBTQ-content.

1) Trans kids know their identity as young as age 2.

There is ample research indicating the struggles trans youth experience in our society. Some of which are documented in a recent trans policy brief I co-authored with colleagues for the National Educational Policy Center. In order to counteract these harms, schools need to be able to talk about gender diversity at early ages to challenge gender stereotypes and make room for kids of all gender identities to be seen, respected, and safe at school and in their community.

2) GLB kids know they are different as young as age 5.

We also know that school and society are difficult places to grow up if you don't identify as heterosexual. Children need to be able to see and understand that there are many healthy, happy GLB people who have made a difference in our world. Learning about LGB history and community members is one way to help GLB youth recognize their identity is not a source of stigma or shame so they can grow up with a healthy sense of pride in who they are. This can also protect them from later engaging in dangerous behaviors that result from homophobia including: drug and alcohol abuse, skipping school, and self-harm.

3) Kids in GLBTQ families deserve to be included at school.

Children who live in GLBTQ-headed households often do not see other families like theirs in books and lessons at school. We know positive relationships with families and communities improve students' engagement at school, so it is essential to talk about GLBTQ people and families with students of all ages.

4) Bullying and name-calling are often based in harmful stereotypes. In order to reduce bullying and name-calling, teachers need to be able to plan and design thoughtful and inclusive lessons about diversity and difference. Some of the most common insults in elementary school are "gay" "lesbo" and "fag". Children may not know what these terms mean, but they know they are insults designed to harm. Educators need to be supported as they implement lessons that address harmful stereotypes to address bullying and reduce these harmful forms of name-calling in elementary school.

5) Kids need to learn an awareness about the diverse world we live in. When we don't talk or teach about GLBTQ people until children are older, we are deceiving them and illpreparing them for the world we live in. They see that official erasure and silence around LGBTQ people and history and learn to believe that it is negative and to be avoided. These lessons endure unless we thoughtfully offer accurate, age-appropriate information for students of all ages. 6) Social studies lessons are not sex ed. Proponents of these bills argue that teaching about GLBTQ topics is "grooming" children for pedophiles or that it is teaching explicitly about sexual behaviors. What inclusive curriculum does is ensures diverse identities, families, and communities are part of the history and stories taught in schools. We talk about straight families and historical figures all the time without mentioning their sex lives. The same is true for LGBTQ families and historical figures.

Schools are responsible for preparing our children to become engaged citizens responsible for our functioning democracy. By officially erasing a large segment of our population (10-12% by most estimates) we are reinforcing negative stereotypes and creating another generation of people who believe LGBTQ people's existence is "inappropriate". Teachers need to have the support of legislation, state standards, and their communities to be able to be effective. Our kids deserve a complete picture of the world we live in. As a judge in Canada once ruled on a case in 2002 for the inclusion of LGBTQ books in a kindergarten classroom, "tolerance is always age-appropriate."

Dear Members of the Social Studies Standards Review Committee,

I'm writing today in response to recent recommendations to remove all references to LGBTQ topics below the 4th grade in the Colorado Social Studies Standards. I am a Coloradoan, a homeowner, a taxpayer, and a gay man.

My experiences in an LGBTQ agnostic public school system during the 1990s and early 2000s made me feel outcast. I grew up attending public schools that made no mention of a person's sexuality in the curriculum, and anything we did "know" came from wild speculation or word of mouth. No one around me said it was okay to be gay. In fact, it was the opposite. Many times, what I learned about LGBTQ topics came through terrible instances of bullying over the course of my time in K-12 schools. In light of my experiences, I have questioned numerous times how the educators and policymakers of that time actually believed they were creating a school environment that allowed all children to thrive.

As a gay voter, I was over the moon when I heard Governor Polis signed HB19-1192 because it meant future generations of public school students might not grow up feeling ostracized as I did. So the recent news about proposed curriculum changes to remove LGBTQ topics from social studies comes as a slap in the face. Unlike HB19-1192, which sought to highlight the strengths of our diverse society, the proposed social studies changes show a school system manipulated to purposefully discriminate against LGBTQ students from cradle to career.

How can the state suggest it is living up to its constitutional provisions to provide a free and uniform education under these proposed guidelines? My child is in 2nd grade and he has a wonderful teacher. By sharing the broad details of her upcoming marriage, she has helped her students to navigate issues like early elementary crushes and boyfriend/girlfriend issues for healthy social emotional development.

I would hate for her to not be able to discuss these issues in class. If she were gay and were marrying her partner, I would hate for self-censure or district or state censure to make her feel like she could not share her full self with the class, because that provides such a rich nurishing environment for kids to feel like their teacher is human and cares about them. Just like my child's teacher did.

My child's teacher is a highly qualified professional, who has undergone more training and licensure than the majority of other career professionals. Daily she must navigate all kinds of unforeseen questions and situations and she should not be hamstrung by what she can talk about in class and her response. I trust that she has the best interest of kids and their healthy development in mind.

Families, whether mom/dad, mom alone, dad alone, grandparents, foster parents, two dads, two mommies, etc are families and are the people who love and care for you. All family types deserve to be honored in the school environment. If a child has two mommies and wants to talk about them at school or share, or have them chaperon a field trip, that should be honored in the same way as a traditional family unit without stigma or censure of the child. Helping children to see that family units may look different than theirs but are all ok should be a goal of the SS curriculum.

I am just as offended that my child's right to openly learn and question might be curtailed by other people's religion invading the public space and that the State of Colorado might cede my rights to theirs.

My son last night asked me why "puto" is a bad word since it sounds so similar to "pluto" and we talked about how bad words in other languages can sound similar to words in English but if it's a bad word, we still shouldn't say it. If that word is going around my son's classroom, I would want the teacher and administration to have all means available to effectively address that situation without worrying that it might run against state policy - where teachers turn a blind eye because they are not supposed to talk about some issues, or where they just tell the kids to talk to their parents, which leaves the kids in the dark.

When my son was 4 he wanted to marry a lizard we found outside. While I tried to talk to him about that not being very practical, eventually I let him explore that space. Children should have a loving supportive environment of professionals versed in child psychology (like his teachers) in which to explore who they are. I don't want my child in an environment where someone else's traditional values are being imposed on his being.

For some children, school is their only safe place. A place to be who they are and have supportive teachers, to get a hot breakfast or lunch. I would not want that safety taken away by teachers having to say "We can't talk about that at school, you'll have to ask your parents." That doesn't mean that teachers and administrators need to provide graphic age inappropriate explanations, but that their judgement as professionals about what to say, how to say it and when should be respected. They are professionals and should be trusted to be professionals, while having the leeway to craft lessons that fit the needs of their classroom and the students in it.

Thank you for taking comments regarding the revisions to CO social studies standards for K-12. My apologies that I write as your hearings are underway this week and Ihope it is not too late to take my comments into consideration. As a retired Colorado elementary educator and a retiree who continues to support minority and LGBTQ+ youth, I believe it is quintessentially critical that curricula reflect the diversity of students within our state's public schools. The power of accurately and authentically representing history and present day communities and cultures cannot be overemphasized. I strongly support the inclusion of LGBTQ+, Black, Indigenous and People of Color in our state's K-12 curriculum and encourage CDE to adopt these revised standards.

I also would like to offer the following observations having read much of the curriculum and scanned other sections:

- I noticed differently-abled people were not mentioned in the list of diverse voices and would suggest adding this demographic.
- 2nd grade Std 1 History Expectations: Line 11 is grammatically incorrect and should read: "compare HOW people" or "influence ON neighbors."
- 2nd grade Std 1 History Evidence Outcomes: Lines 19/20 and 27/28 perhaps c. and f. are redundant?
- 4th grade Std 1 History Inquiry Question #5: Line 4 perhaps should read People WITHIN or FROM Colorado rather than "for."
- 4th grade Std 1 History Nature and Skills: Line 12 remove the words "confrontation of"

- 4th grade Std 1 History Evidence Outcomes: Line 5 Please include Sand Creek Massacre here or elsewhere as an example. A tragic event not to be overlooked in Colorado history.
- 4th grade Std 4 Civics Inquiry Question #2: Line 7/8 (as well as 5th grade Std 1 History Essential Skills #1; Lines 22/23 and 36-38)
 "...diverse opinion/multiple perspectives such as African American, Indigenous, ..." implies that folks within one group always share the same opinion. So I suggest language such as "diverse opinions/multiple perspectives within and between cultural groups" to emphasize that often there exists as much diversity of thought, experience and perspective within a group (Latinx or queer, for example) as between them.
- 7th grade Std 1 History Evidence Outcomes Line 17: letter b. uses "marginalized groups" however unlike other grade levels does not mention African American, Asian American, Indigenous, LGBTQ+ etc. Naming some groups (including differently abled) could be beneficial to instructors/educators.
- 8th grade Std 1 History Outcomes Line 7/8: letter a. "grievances..." mention specific groups Latinos, Asian Americans, LGBTQ+, etc Similarly with 8th grade Std 4 Civics Outcomes Line 22/23 letter a.
- High School Std 1 History Evidence Outcomes Line 30: a glaring omission of Indigeneity across the globe (except in Inquiry Question #7 which seems like an afterthought.) Please include reference to Indigenous peoples worldwide.
- High School Std 1 History Inquiry Question #18 Line 4/5 Another glaring omission of US response to genocide of Indigenous people here and abroad. Please include reference to this dark side of US history and past and present policy.

Thank you again for the opportunity to share my thoughts and I certainly hope the decision-makers at CO Department of Education will adopt the newly revised social studies standards with some or all of the above recommendations.
